
CRPD General Obligations

Article 4 (1): "States Parties undertake to ensure and promote the full realization of all human rights and fundamental freedoms for all persons with disabilities without discrimination of any kind on the basis of disability. To this end, States Parties undertake:..."

Article 4 – General Obligations

Article 4(a-i): "To adopt all appropriate legislative, administrative and other measures for the implementation of the rights recognized in the present Convention;

- b) To take all appropriate measures, including legislation, to modify or abolish existing laws, regulations, customs and practices that constitute discrimination against persons with disabilities;
- c) To take into account the protection and promotion of the human rights of persons with disabilities in all policies and programmes;"
- e) Eliminate discrimination in private enterprises; f) Promote research and development; g/h) research, promote, inform new technologies; i) train professionals



Administrative Implementation

Commission for coordinating implementation: multi-disciplinary, people with disabilities: coordination, timelines and framework for implementation

Legislative Review Body: includes persons with disabilities, experts from across institutions/ministries

Committee for compliance

Review is an audit that can be used as baseline for future monitoring

Other parliamentary and ministry processes required

Permanent Disability Focal Point (cross ministries/levels, responsive to issues)

Identify Framework and external monitoring mechanism (e.g. NHRI)

Process and framework for participation of people with disabilities: who, what, where, how

Legislative Review – To Consider

What are the legal sources in the country?

- **≻** Constitution
- ➤ Legislation
- Codes, standards, regulations
- **→** Policies
- ➤ Programmes



What is the legal context: does the CRPD automatically become domestic law, or is new legislation required?

Legislative Review – To Consider

- Constitution
- Laws related to marginalized populations and should include people with disabilities
- Disability Specific laws (e.g. disability Act)
- Human Rights laws
- Anit-discrimination legislation
- Budgetary legislation

Guardianship laws Civil or Criminal law Healthcare law Electoral codes	Article 12: Equal recognition before the law (legal capacity) Article 13: Access to justice Article 25 - Health
Labour law Vocational training legislation	Article 27 – Work and Employment Article 26: Habilitation and Rehabilitation
Education law Construction law / codes	Article 24 – Education Article 9 - Accessibility
Family law Social Protection laws	Article 19: Living independently and being included in the community Article 23: Respect for home and family



Full Human Rights Implementations

Law/policy: Accessibility Laws / Accessible transportation systems

Programme/Service: transportation service that transports people with disabilities around the community

Non-discrimination & equality

- General compliance
- Allows for transportation and movement within the community

Autonomy

- non-compliance
- Individuals accessing service can not pick a time for transportation (set-times)

Inclusion, participation, accessible

- Non-compliance
- Service is separate from mainstream public bus system (people with disabilities commute in isolation)

International Development Legislation

Article 32: "International cooperation"

- Ensure development programmes are inclusive and accessible
- Provide technical and economic assistance (e.g. accessible technologies)
- Cooperation in research / training and knowledge
- Reform within foreign assistance policies and programs
- Reform policies and codes related to development programming operating within the country
- Moving development policy and programming towards human rights and away from medical perspectives of development



Sustainable Development Goals

- Ensuring disability is include in the national roadmap for SDG implementation and priorities
- Disability inclusive indicators
- Cooperation between disability focal point and the national SDG implementation focal points
- Ensuring SDG monitoring and reporting includes disability indicators

Participation of People with disabilities within the Implementation Process - CRPD

Article 4(3): "In the development and implementation of legislation and policies to implement the present Convention, and in other decision-making processes concerning issues relating to persons with disabilities, States Parties shall closely consult with and actively involve persons with disabilities, including children with disabilities, through their representative organizations."

Article 3(3): "Full and effective participation and inclusion in society"

Article 29: "Right to participate in political and public life"

Successful Engagement

- >Accessible:
 - Physical accessibility (accessible locations)
 - Communication (e.g. captioning, sign-language, alternative text)
 - Open and welcoming platforms for participation (round tables)
 - Monetary resources (e.g. transportation)
 - > Online Platforms for contributions



Successful Participation

Diverse:

- Cross disability representation mobility, sensory, psychosocial, etc.
- ➤ Specific populations socio-economic, ethnic representation, indigenous, gender, children, LGBT, etc.
- ➤ Age seniors, children, youth, adults
- ➤ Geographic representation all regions, rural / urban
- People with disabilities, organizations of people with disabilities, NGOs, interest groups (universities, rights groups), other civil society

Building networks and sustainable partnerships



Types of Participation

- > Members of committees, cross-ministry representation,
- Involved during law reform process (review, revising, new drafts)
- Drafting or revising constitution
- ➤ Involved in training professions
- >Active participation in building policies and programmes
- Community based public platforms
- National treaty reporting process (consultation and representation in person)

On-going – Permanent Engagement

Action based – Meaningful Dialogue

Monitoring for Progressive Realization

Article 33: "Establish a FRAMEWORK to protect, promote, and monitor the implementation of the CRPD. This includes identifying an independent monitoring mechanism"

Monitoring Cycle

Implement

Adjust / Reform for change

Collect
Information &
Data

Report

Analyze

Monitoring Characteristics

- Collects evidence based information, informs successes, gaps, violations, any information related to optional protocol complaints
- Individual experiences, laws, policies, case law, media, etc.
- > Human rights based indicators that can measure progress
- > People with disabilities MUST participate in this monitoring process
- ➤ Monitoring informs reporting to the Committee on the CRPD
