#### **3 – SESSION'S CONTENT, SEQUENCE AND DURATION**

People with disabilities live a number of experiences that frequently reduce their access and/or demand for services: limited resources, discrimination, traditional social norms preventing use of services, visibility, inaccessible programmes etc. Proven links between disability and poverty suggest that development programmes and policies that are not disability-inclusive will leave persons with disabilities behind. Evidence clearly indicates that persons with disabilities are more likely to live in poor households, have limited access to employment opportunities, and have lower education enrolment and attendance rates.

Given the strong linkages between disability and poverty, there has been a growing interest in mainstreaming disability in social protection interventions. Social dimensions of vulnerability can be barriers to accessing secure livelihoods and essential services. In this context, social protection programmes are crucial to improve living standards and access to services, ensuring inclusive and equitable development outcomes. Mainstreaming disability into social protection implies making adjustments in the design and implementation of programmes and policies in order to address the specific vulnerabilities associated with disability.













The right to social protection is enshrined in Article 28 of the UN Convention on the Rights of Persons with Disabilities (UNCPRD) which recognises the "right of persons with disabilities to social protection and to the enjoyment of that right without discrimination on the basis of disability"<sup>1</sup>. The Convention, therefore, gives a clear rationale for a disability inclusive social protection policy. It promotes social protection systems inclusive of persons with disabilities able to facilitate active citizenship, social inclusion and community participation. The Convention calls on States parties to ensure that persons with disabilities receive equal access to mainstream social protection programmes and services as well as access to specific programmes and services for disability-related needs and expenses such as support services.

The variety of actions which could promote an enabling environment for persons with disabilities is many and varied, due to the systematic exclusion experienced by them at all levels of society: improving access to education through programmes which promote the inclusion of children with disabilities in mainstream schools (inclusive education); improving access to health services through early intervention programmes and increased provision of rehabilitation services and supportive devices; improving access to employment through skill development and vocational training programmes.

Social protection programmes can play a central role in alleviating and preventing poverty and vulnerability to secure people's well-being. They can also enhance the employability and economic development of people by creating better opportunities for them. Moreover, social protection can foster social inclusion, participation and improve the enjoyment of rights of persons with disabilities.

Against this background, this webinar aims to discuss why and how States and other stakeholders should ensure the establishment of disability-inclusive social protection systems, in conformity with the UN Convention on the Rights of Persons with Disabilities.

### 9 - WHAT IS BRIDGING THE GAP?
